**OWNERSHIP RIGHTS AND RESPONSIBILITIES**

The Photographer will document the events in a candid manner and take formal portrait and group shots. The Photographer and the Clients agree that unless stated otherwise in this document, the Photographer owns any and all copy or reproduction rights. Where photographs are used online, the watermarked version must be used, and, where suitable, a reference to; <http://www.zndr.co.uk>

Zander Photography may use any photograph for publicity & advertising purposes to promote Zander Photography, this may include publication on the website. Unrestricted open access to client online album will be provided by the Photographer unless otherwise

specifically requested by the client. The disk of full-res images will be of images included in the package, plus any additional prints purchased.

The Clients agree to not reproduce or copy any proof or other photographs of the event, taken by the Photographer, without the Photographer's written permission unless it is for non-commercial use.

**PAYMENT REQUIREMENTS**

To reserve your chosen date, the Photographer requires a deposit payment of 25%, the Photographer will not hold any date open without receipt of said payment. Said payment is nonrefundable for any reason, except if the Photographer cancels this contract.

The remaining balance of £\_\_\_\_\_ must be received by the photographer no later than 14 working days after the wedding date. Failure to do so may result in the clients wedding photography not being released.

**CANCELLATION**

If the Photographer has to cancel this contract for reasons beyond their control (death, injury, sickness etc.) their liability shall be limited to a full refund of all monies paid.

In the event of cancellation by the Clients, after a period of 14 days from the date of signing this contract, as compensation for loss of income to the Photographer the following charges apply as a percentage of the total fee due;

60 days or less before the wedding – 100%, 61 to 90 days before the wedding – 75%, 91 to 120 days before the wedding – 50%. Should the said wedding be a postponement, then, subject to availability, all money paid may be applied to the new wedding date.

In the event of Photographer taking another wedding booking on your cancelled date a full unconditional refund of your deposit and monies paid will be made.

**DISCLAIMER**

The Photographer agrees that every effort will be made to provide high quality photographic services. In the unlikely event that a catastrophic mechanical failure should occur to the Photographer's equipment or transport and the Photographer is unable to provide the Clients with the agreed upon photography services and/or products, the Photographer's liability shall be limited to a full refund of all monies paid.
